Meeting Minutes

President Bill Gunn [KB2GUN] invited guests to introduce themselves.

Zach Thompson [KM4BLG] gave details about the upcoming WCARS (Waynesville) Hamfest. This year it will be Saturday, July 29th, the 5th Saturday instead of the usual 4th Saturday, due to scheduling problems with the site. It will include presentations, fox hunts, exhibits, vendors, indoor and outdoor flea market and food concessions. Bill Gunn said he would be getting an indoor table and invited others to join him if they had anything to sell. Zach mentioned that the Hamfest provides one free table each to nearby clubs, and those present DECIDED that BRARC should request a table every year and pay \$15 to have a second table. If you would like to help or have anything to sell this year, contact Bill.

PRESENTATION

Our presentation this month was by Marv Hoffman [WA4NC], the ARRL North Carolina Section Manager, giving his personal comments on the ARRL in North Carolina. Marv publishes the NC ARRL email newsletter commonly known as *"Greetings from the High Country"*. If you are not receiving it and would like to, email Marv at <u>wa4nc@arrl.org</u> and he'll add you. He also has a version in Word format that is easier for some folks to view.

Marv is the ARRL NC Section Manager through March, 2024. Nominations for the next 2-year term are open in October, with ballots mailed early January for voting thru late February.

Section Managers serve as volunteers, but Marv added that they can request reimbursement for mileage of up to \$4,000/year. Aside from working with the Roanoke Division Director he leads Section activities and keeps ARRL members informed about League affairs. He communicates with ARRL members and his volunteer staff, including going to ARRL and Roanoke Division meetings, hamfests, club meetings and Field Day operations. He is also responsible for providing Silent Key reports.

Marv identified and discussed a series of issues the ARRL deals with: FCC inaction on pending Rule Petitions. Rules change to grant Technician licensees limited HF voice privileges on 75m and 40m. Property Owner Association and Home-Owner Association antenna rules. 300 baud symbol rate limit, which prohibits the use of Pactor 4 by amateurs on HF. The need for digital data sub-bands. Member problems with ARRL email and logging in. ARRL membership flat or declining over five years and the need to get more youth involved in ham radio. \$2 million deficit now covered by unrestricted endowment, which cannot continue.

Marv identified some issues related to the annual deficit. There have been "ambitious" projects including a recent \$1 million computer software upgrade and a new production studio and related equipment in place of the HQ staff operating station. There is consideration of dues changes and/or charges for printed copies of QST or use of services like Logbook Of The World.

Some statistics shared included a loss of over 7,000 ARRL members between 2022 and 2023, and that there are over 760,000 hams in the FCC database, with 378,000 of them being Technicians. Marv suggested that there are probably only about 500,000 active hams in the US, and the rest include deceased hams and those who quit or never did become active. He mentioned a survey that showed that half of newly-licensed Technicians who got their license for emergency communications never turned on a radio during their first year after getting licensed.

Marv next talked about Emergency Communications (EmComm), including ongoing public service and training and as-needed services such as shelter communications during weather emergencies. The ARRL ARES (Amateur Radio Emergency Service) Task Book was updated in 2022, and a full-time Director of Emergency Management was added at HQ. ARRL/ARES and FEMA in 2023 signed a new agreement, in FEMA's words *"establishing our partnership with licensed, voluntary amateur radio operators to support response [and] recovery efforts. We're honored to work side-by-side to meet the needs of millions in the wake of disasters."*

Marv also noted that current nets are not functioning well, partly because they're hard to find and because there aren't enough of them or training for them. EmComm training nationwide has had very few hams taking both required and optional training courses. The League is instituting NTS 2.0 to upgrade ARES and NTS (National Traffic System). They hope to improve the speed and accuracy of messages in the system, to meet the expectations of emergency managers.

No state or territory in the US currently recognizes the ARRL ARES Task Book or the ARES ID Card. North Carolina mandates ICS (Incident Command System) training for its EmComm volunteers. ARES recommends it, but currently doesn't require it. NC operates per the federal Stafford Act and the Department of Homeland Security, requiring ICS training and certification.

AuxComm (*"The North Carolina AUXCOMM Society represents the interests of affiliated volunteer auxiliary communications organizations throughout North Carolina"*) does require ICS training, and Marv said about 25 members in NC have completed the required courses and training, with 175 working on it and another 300 taking the online classes. AuxComm uses SHARES Winlink, which is assigned frequencies and encryption not subject to the QRM of amateur radio frequencies. There are currently 9 RMS stations in NC, 3 provided by the state and 6 by amateurs. The system allows quick and secure communication with Raleigh. Marv concluded with a round of Q&A, and the club thanked him for his presentation.

MEETING ENDED
